#### ARTICLES OF INCORPORATION

OF

#### GENE'S SEAFOOD OF AMERICA, INC.

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

#### ARTICLE I - NAME

The name of this corporation shall be: GENE'S SEAFOOD OF AMERICA, INC.

#### ARTICLE II - PRINCIPAL PLACE OF BUSINESS
