We, the undersigned subscribers, hereby come before the state of Florida for the purpose of becoming a corporation. This corporation is organized by and under the provisions of For-Profit corporation's statutes of the State of Florida.

ARTICLE I

This corporation may engage in computer systems and software development, and manufacture; marketing, and sales, both wholesale and retail; various forms of distribution; repairs to computers and related components; and providing all forms of Internet training and services; and, or in any other activities or businesses permitted under the laws of the state of Florida.
