



**ARTICLES OF INCORPORATION**

**FOR**

**WaveNet Technologies, Inc.**

**Article I.**

**Corporate Name**

The name of this corporation is WaveNet Technologies, Inc.

**Article II.**

**Nature of Business and Powers**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**Article III.**

**Term of Existence**

This Corporation shall have perpetual existence commencing upon filing of these Articles of Incorporation.

**Article IV.**

**Capital Stock**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ten thousand (10,000) shares of common stock having no par value.

**Article V.**

**Registered Agent and Initial Registered and Principal Office**

**Article VI.**

**Board of Directors**

This Corporation shall have two (2) directors initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the stockholders, but shall never be less than one.

**Article VII.**

**Initial Directors**

The name of the initial directors of this Corporation and their street addresses are: Mike Catanese, 10 Southwind Court, Niceville, Florida 32578, and Michael Murdock, 518 Clearbrook Road, Matthews, North Carolina 28105.

The persons named as initial directors shall hold office for the first year of existence of this Corporation or until their successors are elected or appointed and have qualified, whichever occurs first.

**Amendment**
