

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is B.D.C. CARPET, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation shall indemnify any promoter, incorporator, officer or director or any former officer or director, to the full extent permitted by law.




