**AMENDMENT TO ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

2. Except for the change of the name of the corporation, all other articles and provisions of the original Articles of Incorporation shall remain unchanged and continue in full force and effect.

This Amendment to Articles of Incorporation is hereby executed by LAN ANDREWS, as President, and attested by LAN ANDREWS, as Secretary, and shall be immediately filed with the Secretary of State and upon such filing shall operate as an Amendment to the previously issued Articles of Incorporation of the above referenced corporation.
