ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is **CEDARWILD FARM, INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 4675 Stables Way, Wellington, Florida, 33414.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".


ARTICLE VIII - INDEMNIFICATION

IN WITNESS WHEREOF, the undersigned Incorporator has executed these Articles of Incorporation on this 2nd day of November, 1998.


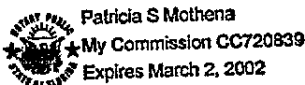


