### ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of this Corporation under the provisions of

Chapter 607 of the Florida Statutes, as amended, adopts the following Articles of Incorporation:

# ARTICLE I: NAME OF THE CORPORATION

The name of the corporation is CONSCIOUS CAREGIVERS REFERRAL HEALTH AGENCY, INC. hereinafter referred to as the "Corporation".

# ARTICLE II: MAILING ADDRESS OF THE CORPORATION
