ARTICLE I - CORPORATE NAME

G. O. TOTAL CONSTRUCTION, INC.

ARTICLE II - NATURE OF CORPORATE BUSINESS

A. Primarily to engage in the general contractor for construction of residential and commercial real estate properties and in general to perform any duties that may be related thereto.

B. To engage in any other business authorized or permitted under the Laws of the State of Florida and/or the Laws of the United States of America.
