ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FLORIDA SURETY BONDS, INC. (Corporation Document # P98000093970)

Pursuant to the provisions of §607.1006, Fla. Stat., this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:

ARTICLE III of the Articles of Incorporation of Florida Surety Bonds, Inc. is hereby amended and restated in its entirety to read as follows:

Article III - Authorized Shares.

The corporation shall have two classes of stock: common shares with unlimited voting rights, called "voting stock"; and non-voting common shares, called "non-voting stock." The classes of stock shall be identical in all rights and regards with the exception of voting rights: owners of voting stock shall be entitled to vote on matters presented to the shareholders, based on their ownership of such voting stock; owners of non-voting stock shall not be entitled to vote on matters presented to the shareholder based on their ownership of non-voting stock.

Each class shall have a par value of \$.01 per share. The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is 100 shares of voting stock, and 900 shares of non-voting stock.

The amendment will be effectuated by the existing shareholders surrendering their current stock certificates in exchange for new stock certificates, with each newly issued share of stock being designated either "voting" or "non-voting." The current ratio of shares owned by the existing shareholders will be maintained in the reissuance of voting and non-voting stock so that no current shareholder's voting rights will be impaired or diminished.

The undersigned, the President and Secretary of Florida Surety Bond, Inc., hereby certify that the foregoing Amendment to the Articles of Incorporation of the corporation was approved by the unanimous consent of all the stockholders entitled to vote of the corporation on the 29th day of

December, 2020. The number of votes cast for the amendment by the shareholders was sufficient for approval.

The amendment to the articles of incorporation shall be effective December 29, 2020.
