The undersigned subscriber, a natural person competent to enter into a contract for the purpose of forming a corporation under the Florida General Corporation Act of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Production ^{Plumbing} Management Company, Inc.

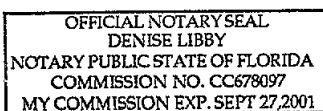
