ARTICLES OF INCORPORATION OF

ARTICLE I-NAME

The name of this Corporation is Magic Auto Services, Inc.

ARTICLE II-INITIAL PRINCIPAL OFFICE

The street address of the initial principal office of this Corporation is 12214 South Spiney Ridge Drive, Jacksonville, Florida 32225.

ARTICLE III-DURATION

This Corporation shall have perpetual existence.

ARTICLE IV-PURPOSE


