ARTICLES OF INCORPORATION

FIRST: The name of this Corporation shall be

KAYTON'S KARS, INC

SECOND: The existence of the Corporation shall be perpetual.

THIRD: The nature of the business and the objects and purposes to be transacted, promoted and carried on are to engage in any lawful act or activity for which corporations may be organized under the Florida General Corporation Act...

FOURTH: The amount of total authorized capital stock of the Corporation shall be divided into 500 shares with no-par value.

FIFTH: The street address of the initial Registered Office shall be 709 W Oak Ridge Road Orlando, FL 32809 and the initial Registered Agent at that address shall be Roger A Foote

SIXTH: The street address of the Initial Principle Office of the Corporation shall be 8000 N Orange Blossom Trail Orlando, FL 32810

Each stockholder shall offer to the Corporation or to other stockholders of the Corporation a thirty (30) day "first right" option to purchase his/her stock should he/she elect to sell his/her stock. Upon the death of any stockholder, the Corporation shall have the right to purchase all shares owned by such stockholder immediately prior to his/her death on the terms set forth above, and this provision shall be binding on the Executor, Administrator, or Personal Representative of each stockholder.
