ARTICLES OF INCORPORATION

OF

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is DAWN'S 1ST CLASS CLEANING, INC..

ARTICLE TWO

The period of its duration is perpetual.


ARTICLE EIGHT
