Articles of Incorporation of DISCOUNT CITY PAGING, INC.

The undersigned do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of florida.

Article I - Name & Address

The name of this corporation is DISCOUNT CITY PAGING, INC. The address is 3737 Loretto Road # 908, Jacksonville, Florida 32223.

Article II - Purpose

This corporation is organized for the purpose of:

- 1. Transacting any and all lawful business for which a corporation may be incorporated under Florida Statutes.
- 2. Transacting telecommunications services to individuals, proprietorships, and corporations.

Article III - Capital Stock
