ARTICLES OF INCORPORATION
OF
ENTERPRISE CONCRETE PUMPING, INC.

The undersigned, acting as incorporator of Enterprise Concrete Pumping, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is:

ARTICLE III: COMMENCEMENT OF EXISTENCE

ARTICLE V: AUTHORIZED SHARES

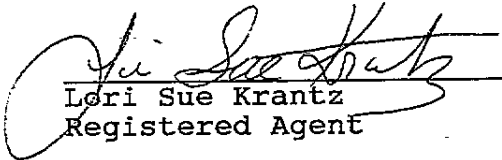
