ARTICLE I - NAME

The name of the Corporation is: FIRST CLASS LAWNS OF NAPLES, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

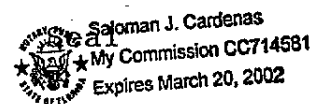
