**ARTICLES OF INCORPORATION**

The undersigned, for purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation shall be: Florida Gardens, Inc. The principal place of business of this corporation shall be 1372 Osceola Drive, Fort Myers, Florida 33901 and the mailing address shall be the same.

**ARTICLE II. NATURE OF BUSINESS**

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.
