ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, being duly licensed to practice law under the laws of the State of Florida, adopts these Articles of Incorporation to form a Corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621 (the "Act"), and other laws of the State of Florida.

ARTICLE I

NAME

The name of this Corporation is Robert L. Beals, P.A.

ARTICLE II

PRINCIPAL OFFICE

The principal office and mailing address of this Corporation is 1900 South Hickory Street, Melbourne, Florida 32901.

ARTICLE III

DURATION

This Corporation shall commence upon execution of these Articles of Incorporation and shall exist perpetually.

ARTICLE IV

PURPOSE

This Corporation is formed to engage in every phase and aspect of the practice of law, and to engage in any other activities allowed by the Act.

ARTICLE V

CAPITAL STOCK

ARTICLE VIII

I.R.C. SECTION 1244

It is the intent of the incorporator to qualify the shares of common stock issued hereunder as "Section 1244 Stock" pursuant to Section 1244 of the Internal Revenue Code of 1986, as amended.

ARTICLE IX

ARTICLE X

AMENDMENT

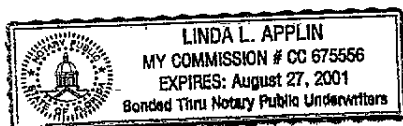
