
## ARTICLE IX

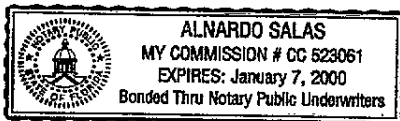


