**ARTICLES OF INCORPORATION**

The undersigned, hereby acts as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

**FIRST:** The name of the Corporation (hereinafter called the "Corporation") is **A BARGAIN AIRFARE, INC.**

**SECOND:** The duration of the Corporation shall be perpetual.

**THIRD:** The purpose for which the Corporation is initially organized, which shall continue to be the purpose of the Corporation until and if the same shall be amended pursuant to the provisions of the Florida Business Corporation Act, and which shall include the authority of the corporation to transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act, are as follows: the sale of airfare tickets, travel documents and travel-related products. The Corporation shall have all of the powers conferred upon corporations organized under the Florida Business Corporation Act.

**FOURTH:** The aggregate number of shares which the Corporation shall have authority to issue is **TEN MILLION (10,000,000)**, all of which are of **PAR VALUE \$.01** each and are of the same class and are to be Common shares.




Designation of Registered Agent
