A PROFESSIONAL SERVICE CORPORATION

The undersigned natural person, competent and licensed to practice as a real estate sales person in the State of Florida, acting hereby as incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the Following Articles of Incorporation:

ARTICLE I -- CORPORATE NAME

The name of the corporation shall be:

ARTICLE II -- PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III -- DURATION

This corporation shall exist perpetually unless dissolved by Florida Law.

ARTICLE IV -- PURPOSE

The general nature and purpose of business to be transacted, promoted and carried on by the corporation is as follows:

a. to engage in every aspect of the practice of real estate sales, and all its fields of specialization, as are engaged in by real estate sales persons;

b. to engage in and render the professional services involved only through its officers, agents, and employees who shall be real estate sales persons in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation;

c. to invest its funds in real estate, mortgages, stocks, bonds and any other type of investment permitted by law;

d. to engage in no other business other than the rendition of the professional services specified herein;

e. to do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE V -- CAPITAL STOCK

a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be one-hundred (100) shares of common stock at \$1.00 per share par value.

b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.

c. Shares of the corporation's stock and certificates shall be issued only to real estate sales persons in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

ARTICLE VI -- INITIAL REGISTERED AGENT AND ADDRESS

The corporation shall have a Board of Directors consisting of one person. The number of directors may be increased or decreased from time to time by a resolution of the majority of the stockholders but shall never be less than one. ARTICLE X -- INFORMAL SHAREHOLDER ACTION

Any action of the shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all the shareholders entitled to vote upon such action at a meeting and filed with the Secretary of the Corporation as part of the corporate records.

ARTICLE XI -- SEVERANCE AND TERMINATION OF EMPLOYMENT

If any officer, director, stockholder, agent or employee of this corporation becomes legally disqualified to render the professional services for which this the corporation is organized, or accepts employment that places restriction of limitation on his continued rendering of such professional services, he shall forthwith sever all employment with the corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the corporation account of professional services, The corporation shall forthwith, upon such disqualification any shareholder, purchase such shareholder's shares and pay him all amounts owing and lawfully due to him by the corporation, except that such shares shall not be entitled to dividends.

ARTICLE XII -- INFORMAL DIRECTOR ACTION

If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the Corporation, and the writing evidencing their consent are filed with the Secretary of the Corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.


ARTICLE XIII -- INDEMNIFICATION
