# ARTICLE II

- To the same extent as a natural person might or could do, to purchase or 2. otherwise acquire, and to hold, own, maintain, work, develop, sell, lease, exchange, hire, convey, mortgage or otherwise dispose of and deal in, lands and leaseholds, and any interest, estate, and rights in real property, and any personal or mixed property, and any franchises, rights, licenses or privileges necessary, convenient or appropriate for any of the purposes herein expressed.
- To manufacture, purchase, or otherwise acquire, and to own, mortgage, 3. pledge, sell, assign, transfer, or otherwise to dispose of, and to invest in and deal in and with, goods, wares, merchandise, real and personal property and services of every class, kind and description, now or hereafter permitted by law.
- To conduct business in, have one or more offices in and to buy, hold, mortgage, 4. sell, convey, lease, or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and in all other state and countries.
- To contract debts and borrow money, issue and sell or pledge bonds, debentures, 5. notes and other evidences of indebtedness, and to execute such mortgages, transfers of corporate indebtedness as required.
- To purchase the corporation assets of any other corporation and engage in the 6. same or other character of business.
