Pursuant to the provisions of Section 607.1003 and Section 607.1006 of the Florida Business Corporation Act, BRANDON ROOFING, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I
Name

The name of the corporation is BRANDON ROOFING, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on November 9, 1998.

Amendment
