ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1003 and Section 607.1006 of the Florida Business Corporation Act, TROUTMEN, REDMAN, WAHOOT & ASSOCIATES, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I
Name

The name of the corporation is TROUTMEN, REDMAN, WAHOOT & ASSOCIATES, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on November 9, 1998.

ARTICLE II
Amendment

Article I of the Articles of Incorporation of this Corporation is hereby amended for the purposes of changing the name of the corporation by deleting the existing Article I in its entirety, and substituting the following therefore to wit:

"Article I
Name

The name of the corporation is "TRW & ASSOCIATES, INC."

ARTICLE III
Date of Adoption

The amendment was adopted on the 24 day of March, 2008.

ARTICLE IV
Manner of Adoption

The amendment was duly approved by the joint written consent to action of the shareholders and the directors of the Corporation.


