A SAMPLE ARTICLE OF INCORPORATION
OF
SOUTHERN DRYWALL STOCKING, INC.

ARTICLE ONE

The name of the corporation is SOUTHERN DRYWALL STOCKING, INC.
(The corporation's name must end with one of the following: Company,

ARTICLE TWO
