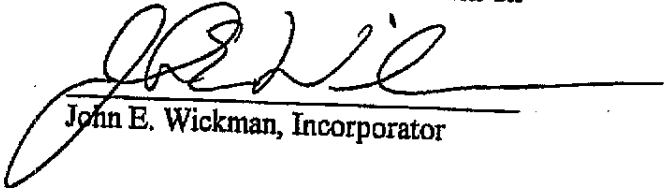
1. Pursuant to Florida Statutes Sections 607.0124, the undersigned incorporator of FLORIDA PREMIER TURF, INC. (filed as "FLORIDA PREMIUM TURF, INC.") (the "Corporation"), hereby submits these Articles of Correction, in order to correct the Articles of Incorporation for the Corporation filed on November 9, 1998, which contained an incorrect statement.
2. Due to a scrivener's error, Article I of the Articles of Incorporation of the above-referenced Corporation incorrectly stated that "[t]he name of this Corporation shall be: FLORIDA PREMIUM TURF, INC., . . . "; the name of the Corporation should have been identified as "FLORIDA PREMIER TURF, INC."
