Thank you for sending me the information I requested concerning dissolution of a corporation. I have enclosed the document that best fit my situation.

I am requesting that the above corporation be dissolved as:

- a. The co-director, J. David Fritchey, abandoned the business on or about March 17, 1999 and without his license the business could not operate.
- b. No shares were ever issued for this corporation.
- c. There was no business received or commenced by this corporation, as Mr. Fritchey did not attempt to market or promote the corporation.
- d. I am unable to operate this type of business without a person who holds a Class C Private Investigators license.
- e. I am pursuing legal charges against Mr. Fritchey both in civil court and through the Division of Licensing.
