ARTICLES OF INCORPORATION OF COLLIER RISK MANAGEMENT, INC., a Florida corporation

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the Corporation is COLLIER RISK MANAGEMENT, INC.

ARTICLE II
