ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is ^{Turner, Moore & Patel, Inc.} and the principal address and principal place of business is 2240 Belleair Road, Suite 160, Clearwater, Florida, 33764.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o PATEL, MOORE & O'CONNOR, P.A., 2240 Belleair Road, Suite 160, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is Sandip I. Patel.

ARTICLE III - PURPOSE
