The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I

The name of the corporation shall be: THE PERFECT TOUCH & HEALING HANDS, INC.

Article II

The initial principal place of business and mailing address of this corporation shall be: 1008 W. Linebaugh Avenue Suite#3 Tampa, Florida 33612. The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it see fit.

Article III

The number of shares of stock that this corporation is authorized to have outstanding at any one time is: (1,000) shares of Common Stock have a par value of \$1.00 per share.

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.

This corporation is to exist perpetually.
