

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF FLORIDA CASINO MARKETING, INC.



Pursuant to Section 607.1007 of the Business Corporation Act of the State of Florida, the undersigned, being the Chairman and Chief Executive Officer of Florida Casino Marketing, Inc., (hereinafter the "Corporation"), a Florida corporation organized and existing under and by virtue of Chapter 607 of laws of the State of Florida (hereinafter "the Corporation"), and desiring to amend and restate its Articles of Incorporation, does hereby certify:

- 1. The name of the corporation is Florida Casino Marketing, Inc.
- 2. The Articles of Incorporation of the Corporation were filed with the Secretary of State of Florida on November 10, 1998, Document #P98000095062.
- 3. The Amended and Restated Articles of Incorporation were adopted by the Board of Directors on March 12, 1999, and by Written Consent Action of the Sole Shareholder on March 12, 1999. To effect the foregoing, the text of the Articles of Incorporation is hereby amended and restated as herein set forth in full and shall supersede the original Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of this Corporation shall be: CASINO MARKETING INTERNATIONAL, INC.

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III NATURE OF CORPORATE BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation shall be to engage in any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE X CONTROL SHARE ACQUISITIONS

This Corporation expressly elects not to be governed by Section 607.0902 of the Florida Business Corporation Act, as amended from time to time, relating to control share acquisitions.

The foregoing articles and amendments were adopted by the Board of Directors of the Corporation pursuant to a Written Consent of all of the Board of Directors of the Corporation, and by the Sole Shareholder of the Common Stock, acting by Written Consent pursuant to Sections 607.0821 and 607.0704 of the Florida Business Corporation Act.
