ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, ATLANTIC GULFSHORE NATURES COVE, INC., a Florida corporation, Document Number P98000095080 (the "Corporation"), in accordance with the written consent of the sole shareholder of the Corporation dated as of April 15, 2002, the Corporation hereby adopts the following amendment to its Articles of Incorporation:


1. Article VI of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following is substituted therefor:
