As per my discussion with Kathy of today, please find enclosed the "Corporation Reinstatement" for Vista Vacations International and a check for \$308.75 representing reinstatement for 2001 and 2001 plus cost of certificate of status.

In May of 2000 we were temporarily purchased by another company who without our knowledge took it upon themselves to file a change as the registered agent. However, after we found out that they were unable to live up to their commitment, we dissolved the agreement in July of 2000 and went back to the original corporation as it was when we started back in Nov. 1998.

Shortly after that horrific experience, we pulled ourselves together and moved to our present address. Most of our paperwork was never returned to us so we did not have knowledge of that change and that combined with the new address kept us from getting the proper notice to renew. Vista Vacations International was never dissolved, but rather continued on as a working, ethical and viable corporation. Under these terrible circumstances, we are hoping that you would be kind enough to waive the reinstatement fee and allow us to please just pay for 2001 as we should have had done a year ago and for 2002 going forward.
