ARTICLES OF INCORPORATION

OF

MARKETING MODELS, INC.

ARTICLE I

The name of the corporation is MARKETING MODELS, INC.

The principal office and mailing address is:

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III

The corporation shall have perpetual existence.


ARTICLE VII

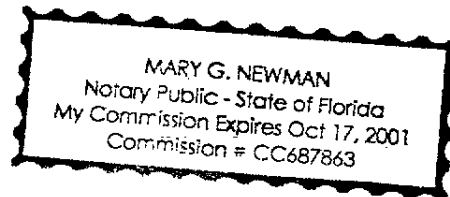
