ARTICLES OF INCORPORATION

OF

TRAFFIC SIGNALS MAINTENANCE, INC.

ARTICLES I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is TRAFFIC SIGNALS MAINTENANCE, INC., and its principal place of business shall be located at 693 N.W. 133rd Way, Plantation, Florida 33325.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of common stock of a par value of One Cent (.01) per share.

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 693 N.W. 133rd Way, Plantation, Florida 33325, and the name of the initial registered agent of this corporation at that address is Marilyn J. Baker.

ARTICLE VII - DIRECTORS

Initially, this corporation shall have two (2) Directors who shall serve until successors have been elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the bylaws. The name and address of the initial directors are as follows:

ARTICLE X - INDEMNIFICATION

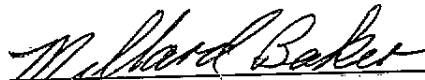

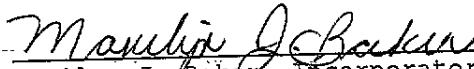
ARTICLE XI - AMENDMENT

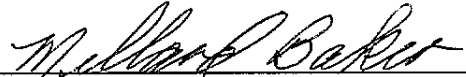

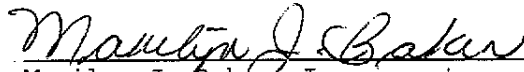

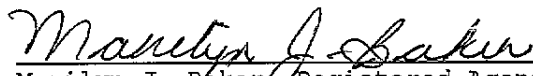
