ARTICLES OF INCORPORATION

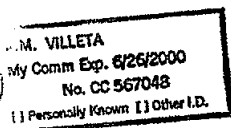

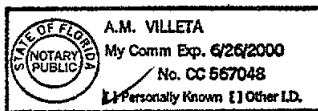

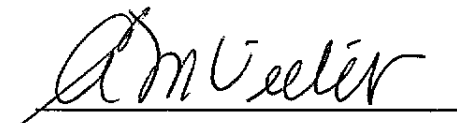
