Dear Sir/Madam:

I represent KDC Development Corporation in various legal matters. Enclosed is the completed 2001 Uniform Business Report for KDC Development Corporation. This report is late for what I hope you will accept as a sufficiently excusable reason to allow you to waive the late fee.

Last year, the annual report form was mailed to the address of record for the business, which unfortunately had been destroyed by fire a few months prior. Therefore, the 2000 report form was returned to your office by the postal service as undeliverable. Sometime in October, I became aware that this corporation had not filed its annual report, and took steps to correct the situation. At that time, my client requested that I take whatever steps were necessary to ensure that future annual report forms were sent to my law office so they would be promptly completed and returned. At that time, I changed the registered agent designation to me and provided my office address, under the belief that the report form would come to the registered agent.

However, I have just learned from my client that earlier this year he received an annual report form, but did not think he needed to respond since he believed I must also be receiving a report form as registered agent. In the last few days, he received a second notice and contacted my office to see why we had not timely completed and returned the annual report for 2001. I spoke with your office and learned that the annual report form is not mailed to the registered agent's address, but to the mailing address for the corporation. On that basis, I have changed the mailing address to the registered agent's address so this is finally set up to work correctly.

I hope you will consider this sufficiently excusable neglect to provide a basis for you to waive the penalty and accept the enclosed renewal.
