ARTICLES OF INCORPORATION

of

THE WARFIELD GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE I CORPORATE NAME AND PRINCIPAL ADDRESS

The name of this Corporation is THE WARFIELD GROUP, INC. The principal address of the corporation is 741 N.W. 37th Street, Ft. Lauderdale, Florida, 33309.

ARTICLE II PURPOSE

The general purposes for which the corporation is organized are:

- 1. To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
- 2. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE III DURATION

The duration of the corporation is perpetual.
