**ARTICLES OF INCORPORATION
OF
AMICUS DISTRIBUTORS, INC.**

ARTICLE I - NAME

The name of this corporation is **AMICUS DISTRIBUTORS, INC.**, and the principal address of the corporation is **7240 S.W. 13th Terrace, Miami, Florida 33144-5310.**

ARTICLE II - PURPOSE

This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated in the State of Florida.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of common stock at One Dollar (\$1.00) par value.

ARTICLE IV - PREEMPTIVE RIGHTS AND RIGHT OF FIRST REFUSAL

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase a prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which is offered to others. Any existing shareholder who wishes to sell any of his/her stock in the corporation must first offer those shares to all other stockholders of the corporation on the same terms and conditions that he/she would sell them to a third party.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is:
7240 S.W. 13th Terrace, Miami, Florida 33144-5310, and the name of the initial registered agent of this corporation at that address is: Luis Ramirez.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

This corporation shall have three directors initially. The number of directors may be either increased or diminished from time to time as provided for in the By-Laws, but shall never be less than one. The names and addresses of the initial directors of this corporation are: Luis Ramirez, 7240 S.W. 13th Terrace, Miami, Florida 33144-5310; Denset Serralta, 7240 S.W. 13th Terrace, Miami, Florida 33144-5310; and Jelsys Serralta, 7240 S.W. 13th Terrace, Miami, Florida 33144-5310.

ARTICLE VII- DURATION

This corporation shall have perpetual existence commencing at the time of filing of the Articles of Incorporation with the Secretary of State.

ARTICLE VIII- INCORPORATOR

The name and address of the incorporator signing these Articles of Incorporation is: Luis Ramirez, 7240 S.W. 13th Terrace, Miami, Florida 33144-5310.

ARTICLE IX- BY-LAWS

The power to adopt, amend or repeal the By-Laws shall be vested in the Board of Directors and the Shareholders.

ARTICLE X - AMENDMENT TO ARTICLES OF INCORPORATION

The Articles of Incorporation may be amended as provided by law.

ARTICLE XI- VOTING RIGHTS

The entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding shares of common stock.

ARTICLE XII - GENERAL OPERATION PROCEDURES

The affairs of this corporation shall be conducted by the initial board of directors until such time as the stock of the corporation is issued to the subscribers of the stock of the corporation. The authority of the initial board of directors shall include: (1) the

adoption of the Articles of Incorporation, and (2) such other activities as are necessary to the administration of the affairs of this corporation during the period of time prior to the issuance of stock to the subscriber and the meeting of the first Board of Directors. Once the stock of the corporation has been issued, the affairs of this corporation shall be conducted by the stockholders and the Board of Directors according to law.
