# ARTICLES OF INCORPORATION OF DOOR DEPOT OF PALM BEACH, INC.

The undersigned hereby makes, subscribes, acknowledges, and files these Articles for the purpose of becoming a corporation under the Laws of the State of Florida.

## ARTICLE I Name of Corporation

The name of this corporation shall be DOOR DEPOT OF PALM BEACH, INC.

# ARTICLE II Principal and Mailing Address

## ARTICLE III Perpetual Existence

The corporation shall begin its existence upon the filing of these Articles of Incorporation by the Secretary of the State of Florida and shall have perpetual existence thereafter.

#### ARTICLE IV Authorized Business

The corporation shall be authorized to engage in any business or activity permitted under the laws of the State of Florida and of the United States.

#### ARTICLE V No Limitation of Powers

Nothing in these Articles of Incorporation shall be taken to limit the power of this corporation.

- A. One director shall constitute the initial Board of Directors of the corporation, but the by-laws may provide for such increase or decrease in number thereof as authorized by law.

#### ARTICLE IX Preemptive Rights

The shareholders of the corporation shall have full preemptive rights.

#### ARTICLE X Share Structure

The aggregate number of shares which the corporation is authorized to issue is 10,000. Such shares shall be of a single class of common stock and shall have a par value of \$1.00.

#### ARTICLE XI Transfer of Shares

Before there can be a valid sale or transfer of any of the shares of the corporation by any holder thereof, such holder shall first offer said shares to the corporation and then to the other holders of

that he shall not sell or transfer such shares at a lower price or on terms more favorable to the purchaser or transferee than those specified in his notice to the Secretary of the corporation.
