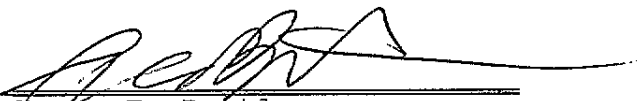
ARTICLE VIII

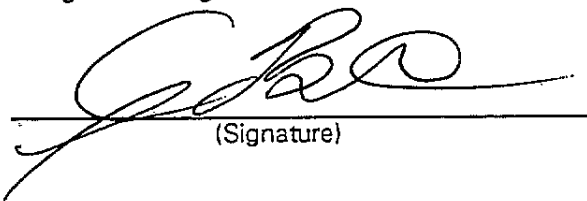
