The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is: **RAZZAMATAZZ**. The mailing address for the Corporation is: **105 Bonita Place, Ormond Beach, Florida 32174**.

ARTICLE II - NATURE OF DURATION

The term of existence of the Corporation is perpetual.

ARTICLE III - NATURE OF BUSINESS





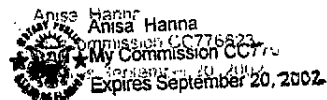
