

ARTICLE II. STOCK. The corporation is authorized to issue 100 shares of common stock at \$1.00 par value per share.


ARTICLE III. ADDRESS. The initial street address of the principal office of the corporation is 7145 Crescent Creek Way, Coconut Creek, FL 33073.


