1. The name of the Corporation is C4 CAPITAL CORP.
2. Article I of the Articles of Incorporation of the Corporation are hereby amended to change the name of the Corporation from C4 CAPITAL CORP. to HFS-USA, INC.

To effect such amendment, Article I of the Articles of Incorporation is hereby amended and restated in its entirety to read as follows:
