NAME**

The name of this Corporation is MacCup , Inc.

**ARTICLE II
DURATION**

This Corporation shall have perpetual existence.

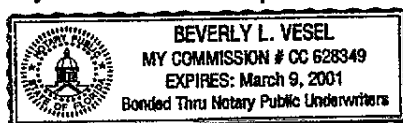
