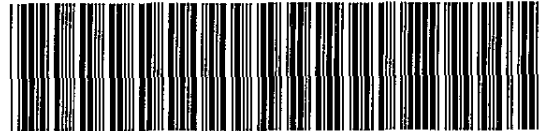

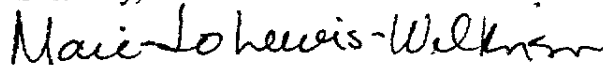

1. The name of the corporation to be dissolved is Citrus Creek, Inc., Document No. P98000095900 (the "Company").
