

The name of this corporation is G & G OF SARASOTA, INC.

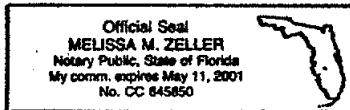
