ARTICLES OF INCORPORATION OF MDT ENTERPRISES, INC.

ARTICLE I

A, the undersigned, acting as incorporator of a corporation under Chapter 607 of the Florida Statutes, do hereby adopt the following Articles of Incorporation for MDT ENTERPRISES, INC.

CORPORATE NAME

The name of this corporation is MDT ENTERPRISES, INC. with the principal office address being 1788 Otisco Way, Winter Springs, FL 32708.

ARTICLE II

NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to install and repair irrigation systems and any other business permitted under the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred (100) shares of common stock, having a par value of \$10.00 per share.
