ARTICLES OF INCORPORATION
OF
CCI OF SOUTHSIDE, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: CCI OF SOUTHSIDE, INC.

The address of the principal office of this corporation shall be: 4225 Genesee Street, Buffalo, New York 14225, and the mailing address of the corporation shall be the same.

ARTICLE II - NATURE OF BUSINESS

The business activities of this corporation are limited to the development and operation of one or more T.G.I. Friday's Restaurants.

This corporation is to exist perpetually.


ARTICLE VI - INCORPORATOR
