Unfortunately, we did not receive the first forms indicating it was time to pay the yearly corporate fee of \$150 for each corporation. Our companies have two locations. Part of the year we are located in Boca Raton, Florida and the other part of the year we are located in Manhattan, New York. Typically, our mail is forwarded to us at our various locations. However, sometimes the post office fails to send us our mail in a timely fashion and sometimes we do not receive the mail at all.
